

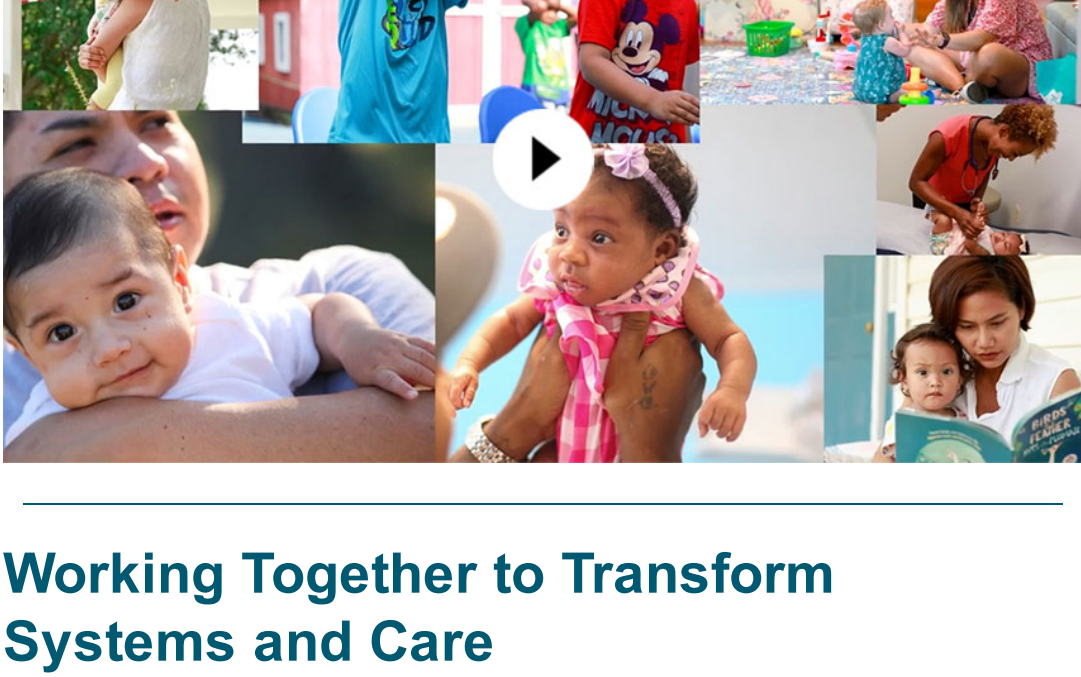

Happy holidays from the ECDHS: Evidence to Impact Center!

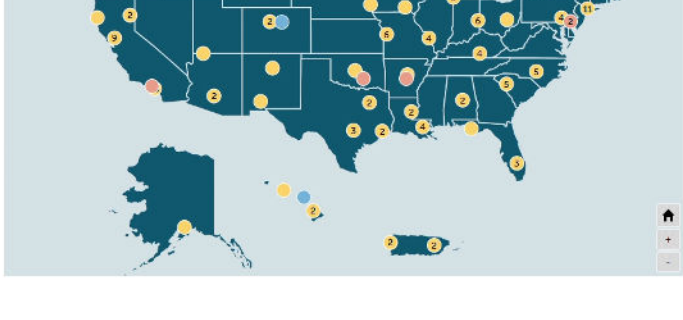

We're also excited to share two new resources highlighting the state, territory, community and Tribal teams we work with.

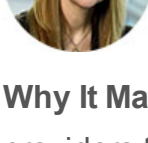

Elevating Comprehensive Services With the Well Visit Planner

The Well Visit Planner approach and tool helps health professionals engage families as partners in their child's care, promote early relational health and child flourishing, and build the trust needed to effectively address family priorities and address risks.

"We have to work together. The Well Visit Planner allows for a "through any door" approach where families can be engaged wherever they are and linked to quality whole child and family well child care, as well as other supports across systems."

Why It Matters: Well visits are a critical opportunity for families and health providers to connect, but there are wide gaps in the utilization and quality of services that require innovative, family-centered strategies.

- The Well Visit Planner ensures the universal provision of care that aligns with Bright Futures guidelines. It enables real engagement with families and "through any door" collaboration across early childhood systems.
- The Well Visit Planner features a brief family-facing digital tool, available in English and Spanish, that streamlines and integrates comprehensive screening and priority setting while educating and helping families and health professionals focus well-visit time on the unique needs, goals and priorities of each child and family.

New EPSDT Guidance for States

The Centers for Medicare & Medicaid Services (CMS) recently released new guidance on Early and Periodic Screening, Diagnostic and Treatment (EPSDT) requirements for eligible children enrolled in Medicaid and CHIP. The guidance discusses policies, strategies and best practices for states to maximize health care access and utilization.

Why It Matters: The EPSDT benefit provides comprehensive and preventive health care services for eligible children, with the primary goal of providing "the right care, to the right child, at the right time, in the right setting."

What States Can and Should Do: To implement EPSDT, health and systems leaders should align with best practices to prioritize prevention and early intervention, ensure access to a full range of health services, expedite medical necessity determinations, set clear expectations for managed care organizations and accountable care organizations, and report on child health outcomes.

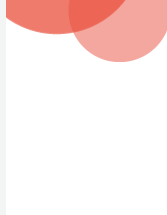


Community Health Center Corner

Community health centers play a pivotal role in providing high-quality early childhood developmental health services. Below is a new resource along with insights from a needs assessment survey administered to health centers late last year.

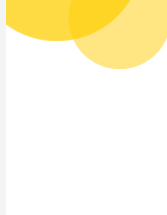

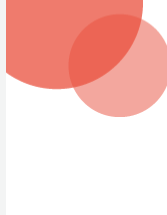
Road Map for Policy Changes to Transform Child Health Care

A [recent report](#) from the National Academies of Sciences, Engineering and Medicine lays out a road map for policy change and health care system transformation to better meet the needs of children and families. The report's recommendations call for sustained and coordinated leadership at the federal level on children's health and emphasize the need to better assess the impact of public policies.



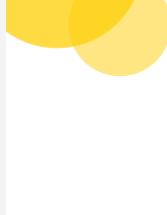
Building for Babies: State Policy Self-Assessment Suite

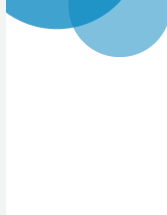
Literacy Promotion: A Vital Part of Primary Care

The AAP's [updated policy statement](#) and [new technical report](#) emphasize the importance of reading with young children to promote development. The policy statement includes recommendations for how pediatricians and pediatric advanced care providers can promote literacy development at health supervision visits from the newborn period through kindergarten.



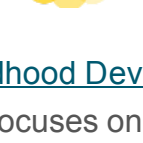
Language Access Services Online Course
